### NOTICE OF PUBLIC HEARINGS

The City of Cedar Hill has received the application (on file in the Planning Department) described below. Public hearings will be conducted on the dates, times and locations stated in this notice.

**Cases No. CUP-254-2020R** – An application to revise the Conditional Use Permit for a winery with the sale of alcoholic beverages for on-premise consumption and to add “indoor and outdoor commercial amusement” [Saviana Winery] on property zoned Old Town Corridor within the Uptown Overlay, and located on the south side of Cooper Street, west of Highway 67 with the approximate address being 316 Cooper Street.

In addition to the existing winery, the applicant requests to have events at this location.

You are receiving this notice because you are a property owner within 200 feet of the boundary of the proposed request. If you are unable to attend the public hearings, written comments may also be submitted. If you would like to register opposition to this request, a written protest signed by the property owner should be received by the Planning Department prior to the close of the City Council Public Hearing.
