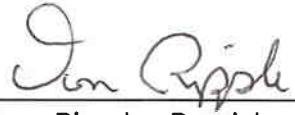

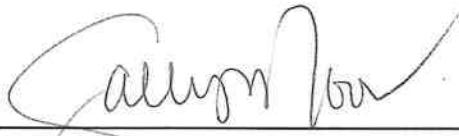
**V. Conduct a Workshop to Discuss the Parks and Recreation Capital Improvement Program.**
