I. Call the Meeting to Order.

Rick Cook called the meeting to order at 7:03 pm.

II. Consider Approval of the November 15, 2017 Minutes.

IV. All Sports Board Annual Report.

Rodney Thornton, President of the Cedar Hill Youth Basketball Association, reported that for the Winter league they had 47 teams with 10 youth per team the ages ranging from 4 to 14.

Clint Farrell, President of the Cedar Hill Youth Baseball Association, reported that Spring league had 500 and Fall had 300 of which 85% were Cedar Hill youth. For their tournaments, they bring in 100 teams from the DFW area.

Anthony Judge, President of the Cedar Hill Youth Football Association reported that for the Fall season they had 200 youth. Of those youth, less than 50% were Cedar Hill youth.

Carlos Pacheco, President of the Girls Softball Association, reported that Spring and Fall are 100% recreation league, with the select teams being offered in the Summer. The recreation leagues had 652 youth. Of those youth, 70-80% are from Cedar Hill.

V. Park Land Dedication Update.

Denis Sims, a consultant from Dunkin Sims & Stoffels, Inc., gave a presentation to the Board regarding the City's park land dedication fee. He presented what other cities in the area are charging for fees, changing park service areas and a possible new fee for Park Land Dedication and Park Development in Cedar Hill.

VI. Parks Master Plan Update Kick Off.

William Ford, Parks and Recreation Director, gave a brief overview and timeline to the Board regarding the Parks Master Plan Update. He made them aware that at the next meeting they will need to nominate some members for a Parks Master Plan subcommittee.

William Ford, Parks and Recreation Director, informed the Board of the 5 year plan regarding the Bond implementation and how the money will be used. He specifically highlighted items that would affect the Parks and Recreation Department.
