

CEDAR HILL PARKS AND RECREATION BOARD
WEDNESDAY AUGUST 15, 2018
MINUTES

The Cedar Hill Parks and Recreation Board met August 15, 2018 at 7:00 p.m. at the Cedar Hill Government Center, 1st Floor, Multi-purpose Court Room, 285 Uptown Blvd. Bldg. 100, Cedar Hill, Texas.

I. Call the Meeting to Order.

Rick Cook called the meeting to order at 7:04 pm.

II. Consider Approval of the July 18, 2018 Minutes.

Dustin Ledbetter made a motion to approve minutes. Clara McGinnis seconded the motion, and the motion carried unanimously.

III. Citizens Forum.

Toni James gave recommendation that the new Outdoor Community Swimming pool be moved to the Alan E. Sims Recreation Center and not Virginia Weaver Park. Ms. James explained that the Virginia Weaver site would increase traffic in the neighborhood. Ms. James also expressed concerns about the safety and security of the pool and who will monitor it after hours.

Tracy Jeffers, Vice-President of the Cedar Hill Soccer Association, expressed his concerns on losing the Soccer fields at Crawford Park. Mr. Jeffers explained that the practice fields are detrimental to the Cedar Hill Soccer Association. Mr. Jeffers gave recommendation that the new Outdoor Community Swimming Pool be located anywhere except at the Crawford Park Site 1b.

Tim Miller, A 20-year resident of Cedar Hill, gave recommendation that the new Outdoor Community Swimming pool remain at Crawford Park. Mr. Miller expressed that he prefers a Community Swimming pool instead of a Waterpark.

David McDaniel, A 9-year resident of Cedar Hill, gave recommendation that the Outdoor Swimming pool remain at Crawford Park as part of the City Center Development Plan. Mr. McDaniel expressed that moving the Swimming Pool to a

different location might affect the decision of potential Developers and Investors in the future.

Dr. Deborah Cawthon gave recommendation that the new Outdoor Community Swimming pool remain at Crawford Park, close to the City Center and near Preston Trail Apartments. Dr. Cawthon expressed that the current pool location serves the needs of the citizens who live on the West Side of Highway 67. Dr. Cawthon expressed that she prefers the pool remain at the current site Crawford Park 1A or at Crawford Park 1B, where the soccer fields are located.

V. Review and discuss additional public comment from "Let's Talk Cedar Hill" and the most recent public input meeting on August 7, 2018 on the new Outdoor Community Swimming Pool.

Carolyn Skeels, Recreation Superintendent; Shonda Johnson, Recreation Operations Supervisor and John Jackson, Recreation Coordinator gave a presentation on the new Outdoor Community Swimming Pool. Rose Mercer made a motion to have another joint Board meeting with the Cedar Hill Community Development Corporation to consider additional public comment on the new Outdoor Community Swimming pool location. Kiphani Allen seconded the motion. The Cedar Hill Parks and Recreation Board voted 4 to 3, with 4 voting against and 3 voting in favor and the motion failed. After further discussion, the Cedar Hill Parks and Recreation Board confirmed previous recommendation to move the new Outdoor Community Swimming pool to the Virginia Weaver Site.

William Ford, Parks and Recreation Director, presented the Board with additional public comment from "Let's Talk Cedar Hill". The Cedar Hill Parks and Recreation Board

confirmed previous recommendation to use Schematic Design 3 for the new Creative Playground.

VII. Consider approval of Bradford Park Reinvestment Design.


