FYI

I read in our church bulletin that there will be an event at the Virginia Weaver Park in Cedar Hill. I remember this lady and Elmer Weaver and have no problem with naming parks for them and streets and even highways. However, I need to say something in this regard. I am 81 years old. I was born in a frame house almost on the Dallas, Ellis County line - my aunt's house, in the dead of winter. Until a very few years ago I could still see the top of the house from Hwy 67 - it adjoined my grandmother's farm, not sure if it's still there now. That said, I will get to my point. My dad was born in the same house, his mother was born in that vicinity, he and all his 7 siblings were born and grew up there. Most of my family members are buried in the Valley Seminary, including my parents, my daughter, brother, brother-in-law, grandson, aunts and uncles, cousins, grand parents and many more. According to Rose Plummer, one of my earliest school teachers, my dad drove another man, in our car, out of state to bring back Cedar Hill's first school bus. My mother made the little uniforms - capes and skirts and trousers, for the first "rhythm band." She also made the first hats for the high school majorettes - circa 1949/50. My dad personally bought and paid for all the equipment, organized and coached the first little league baseball team in Cedar Hill and many of Cedar Hill's old settler families had boys on that team. He also organized one of the first high school age summer boys baseball teams. My mother took up money at the high school games to purchase a "record player" which was used at each home game for the "pep squad" - majorettes - and cheer leaders to march and perform to, long before anyone thought of a band. The reason I mention Rose Plummer, who taught me and each of my children in 3rd grade, is because I was too small to remember the school bus and mother sewing the little uniforms. I still have my dad's score book and a couple of pictures and have submitted them to the city before. I think no one was interested. I am interested. There are only a few folks left living who remember playing summer baseball on my dad's team - only a few who remember my mother sewing for and taking up money for the school - soon there will be none left. And so I write in hopes someone will read this and these things will be recorded and remembered. I still don't understand why we have parks named for people who came to Cedar Hill long after my dad was born here and whose history here is predated by far by my dad and his family. My parents were an integral part of the history of this town, when - in fact - it was a town, population under 1000 - and I have many stories and many memories I have collected over my 80+ years - - - they matter to me.
