- I. **Call the Meeting to Order:** Rick Cook, Park & Recreation Board Chairman; called the meeting to order at 7:06pm.
- II. **Citizens Forum:** No Citizens present.
- III. **Review minutes from joint Park Board & CDC Board Meeting held on January 16, 2020.** Marilyn Little made the first motion to approve minutes and Neil Bolton seconded motion and the motion carried unanimously.
- IV. **Review minutes from joint Park Board & Library Board Meeting held on February 19, 2020.** Neil Bolton made the first motion to approve minutes and Clara McGinnis seconded the motion, due to technical difficulties during the Zoom teleconference, second was not carried. The Parks and Recreation Advisory Board would like to take this opportunity to thank you for speaking during the Community Forum at the Parks/Library joint meeting held on February 16, 2020. At this meeting you submitted a letter from Margaret Nell Nutting Camp Cheek requesting to have a park named after her father. We sincerely appreciate you sharing with us this bit of Cedar Hill history. In her letter, Ms. Cheek relayed both her family ties to our community and the significant contributions her father made during the early days of youth sports in Cedar Hill including his significant role in organizing the first Little League Baseball team in Cedar Hill.

I personally want to thank you and Ms. Cheek for the letter and history of her family and the important role they played in getting boys and girls involved in sports in Cedar Hill. The Parks and Recreation Advisory board is always excited to hear how citizens have contributed to the growth and development of this great city.

Ms. Cheek's written request to have a park named after her father led to a robust discussion at the next Parks and Recreation Advisory Board meeting on April 15, 2020 with a decision to continue the discussion at our next meeting. At the May 20, 2020 board meeting, we included an agenda item to discuss nominating a sub-committee to define procedures for managing park naming nominations from the community. After another robust discussion, board members determined the procedures we have defined in compliance with the current Code of Ordinance (Sec. 15-27) "*Naming of Parks*" is sufficient for naming parks. When we have park facilities which require naming, our procedures include solicitation of proposed names from the community and processes for vetting those names. We concluded our current procedures are sufficient, and the board voted that no subcommittee to review those procedures is necessary at this time. We look forward to working with you and the rest of our residents when we solicit community input during the next park naming opportunity.

In closing, I want to take this opportunity to thank you and the Nutting family for all that you have done to make Cedar Hill a wonderful community with excellent parks and recreation venues.
