The Zula B. Wylie Public Library Board met Wednesday, July 30, at 6:00 p.m. via Zoom.

**I. Call the meeting to order.**

The meeting was called to order by Vice President Mary Sadousky at 6:06 p.m.

**II. Approve minutes from June 2020 meeting.**

**III. Received update on library – COVID 19 Procedures**

Aranda was excited to share that the design process for the new library is in full swing. Aranda thanks and acknowledged the Library Board members who also were a part of the Community Design Team who met last week. August 27, 2020 at 6:00pm there will be a joint meeting with Parks and Rec and Julie Gutierrez. It will be at the Rec Center in the meeting rooms.

Ms. Bell also thanked the board members for their flexibility in meeting times and dates, as there have been many changes. In September, we'd like to plan for a "video" Zoom meeting.

The floor was opened for questions:

Mary Sadousky asked for an update regarding upcoming city events. Ms. Bell updated that Country Day was cancelled. There are meetings scheduled to discuss options for other events such as Scare on the Square and Holiday on the Hill.

Jackie Moore asked if there was an update on KOHA and if it had been reviewed by our legal team. Aranda responded that it is still being reviewed.

Aranda also added that September is National Library Card Sign-up month. A proclamation will be given at City Council. More information will be given as we approach September.

## **VI. Library Friends Report**

Elaine Cook shared that \$2000 was donated to the library to support the purchase of STEM backpacks for checkout. The Friends will be identified on the backpack using luggage tags.
