I. Call the Meeting to Order:

III. Review minutes from Park Board meeting held on January 20, 2021:

Clara McGinnis made the first motion to approve minutes and Antione Scott seconded motion and the motion carried unanimously.

IV. Receive Annual Soccer, Baseball & Basketball Reports from Cedar Hill All Sports Association:

Shonda Johnson introduced the associations for Soccer, Baseball & Basketball. Each president of the associations gave details pertaining to the sport they represent. All associations announced they are ready to start the season, with few questions listed below from the board. All questions were answered, and Shawn Ray commended the association presidents on how they handled the challenges due to the pandemic.
