I. Call Meeting to Order:

Elizabeth called the meeting to order at 6:30PM

II. Citizen's Forum:

Chris Haley and Christen Griffith introduced themselves as member of Neighbors of Sleepy Hollow. Kim Rimmer spoke in opposition of the CHISD Bond/VATRE election.

III. Approve the Minutes of the September 19, 2022, Regular Meeting:

Kim made a motion to approve the minutes of September 19, 2022, seconded by Darian. The motion passed unanimously.

IV. Review Matching Grant Application – Sleepy Hollow:

Board members reviewed the application submitted by the Neighbors of Sleepy Hollow. Since the projects are not fully completed, Sherman made a motion to approve the application with \$1,500 to be released upon City Council approval, then remaining \$1,000 released once receipts are submitted totaling \$1,500 for a full \$2,500 grant, seconded by Sabrina. The motion passed unanimously. The board asked the Neighbors of Sleepy Hollow to submit a timeline of completion to submit to council. This item will most likely be on the November 8th City Council agenda.

V. Discuss Citywide Block Party 2023:

Tia gave an update to the board that the Cedar Hill Block Party will be held at the Alan E. Recreation Center, Saturday, March 4th from 9am to 1pm. Once the new library is completed, this annual celebration will most likely be moved to the Government Center. Elizabeth suggested renaming the event "Party on the Hill".

Kim and Melissa would like to change the month of the celebration to sometime in April or May.
