1. Call meeting to order.

2. Introduction of meeting attendees.

3. Business Items:

- A. Approve Board meeting minutes for the September 08, 2022**
 - Approved September 08, 2022, Meeting Minutes with one correction – Tellers Report to be typed out within agenda instead of attaching.
- B. Receive Board Treasurers Report**
 - Ruby Martin, Board Treasurer, gave the treasurer's report.
- C. Code Enforcement Presentation**
 - Kevin Quintanar, High Pointe's new code enforcement agent, gave a presentation and opened the floor for questions:
 - i. Code Enforcement handles junk cars (parked for 30 days or longer with expired stickers or is inoperable) parked on private drives, unrepainted fences that face a right of way or have a pet or a pool, and bulk trash set out too early.
 - ii. Police handle junk cars on the street.
 - iii. Animal control should be called for loose dogs using the Cedar Hill non-emergency number– 972-223-6110, option 4.
 - iv. At your door service is now available for the proper disposal of chemicals and certain electronics – use the myCedarHill App to request a plastic bag and pick-up time.
- D. Introduction of Business Manager**
 - Amanda Hawkins, the new business Manager for Highpointe PID #1 Introduced herself.
- E. Cedar Hill Police Department Sargent Adams**
