MEETING MINUTES  
THURSDAY, FEBRUARY 16, 2023**

The Beautification & Environmental Sustainability Board met on Thursday, February 16, 2023, at 6:00 p.m. in the Council Briefing Room located at the Cedar Hill Government Center. **I. Call meeting to order**
