CITY OF CEDAR HILL BEAUTIFICATION & ENVIRONMENTAL SUSTAINABILITY BOARD MEETING MINUTES THURSDAY, MAY 16, 2024

The Beautification & Environmental Sustainability Board met on Thursday, May 16, 2024, at 6:00 p.m. in the CHISD Conference Room of the Cedar Hill Government Center. The following Board members were present: Bertha Middlebrooks, Lisa Lathon-Brooks, LaTambra Gibson, Brian Hart, Nikita Russell, Dr. Lester Singleton, and Carol Sosebee. The following Board members were absent: Andrew Adams, Patricia Diaz, Sylvia Johnson, and Robert Largent. The following City staff members were present: Lauren Betz and Marie Watts.

I. **Call meeting to order**

Middlebrooks called the meeting to order at 6:02 p.m.

II. **Approve minutes of April 18, 2024 meeting**

Gibson motioned to approve the minutes of the April 18, 2024 meeting. Singleton seconded the motion. The motion passed unanimously.

III. **Citizen's Forum**

Middlebrooks opened the Citizen's Forum. No comments were received. Middlebrooks closed the Citizen's Forum.

IV. **Review and approve draft Community Garden Commitment Form**

The Board reviewed the Community Garden Commitment Form and requested that verbiage be added that states use of pesticides and weed killers/herbicides is prohibited. Singleton motioned that the commitment form be approved with the revision. Gibson seconded the motion. The motion passed unanimously.

Betz provided potential dates for the Community Garden Meet & Greet in June. After discussion, the Board voted to hold the event during the Board's regularly scheduled June meeting date, Thursday, June 20th at 6 PM in the CHISD Training Room on the 3rd floor of the Government Center. Betz told the Board that the event would include guest speakers who are experienced, active gardeners.

BES Board members requested that eligible gardeners that were on the Discovery Garden's wait list be contacted and invited to the event. They also asked staff to secure door prizes for attendees.
