Shawn Ray shared with the Board the new live-streaming bird bath located at the Singleton Preserve, which can be viewed on YouTube. He mentioned that several birds, including a cardinal and a dove, were seen during the live stream that took place during the meeting. Shawn also introduced the new ClearGov site, which will provide clear and transparent information regarding City spending and project updates. He explained how the data will be measured and compared to similar cities. The ClearGov platform is expected to launch at the beginning of the year.

Chair, Antoine Scott adjourned the meeting at 8:02 p.m.


