**MINUTES**  
**PLANNING AND ZONING COMMISSION**  
**Meeting of August 2, 2016**

*The Planning and Zoning Commission of the City of Cedar Hill, Texas met on TUESDAY, August 2, 2016 at 6:00 p.m. in the T.W. "Turk" Cannady/Cedar Hill Room, 285 Uptown Blvd, Bldg. 100, Cedar Hill, TX.*

**I. Call the Meeting to Order**

Chairman Brooks called the meeting to order at 6:02 p.m. declaring it an open meeting in which a quorum was present and the meeting notice was duly posted.

**II. Approve the minutes of the July 19, 2016 regular meeting**

A motion was made by Commissioner Deeds and seconded by Commissioner McCurdy to approve the minutes of the July 19, 2016 regular meeting. The vote was as follows:

**IV. Case No. 16-20 – Review and consider a preliminary plat and layout plans for the Destiny Worship Center Addition, Block A, Lot 1, located on the south side of West Parkerville Road, east of Burney Court; requested by Cannon R. Henry on behalf of Phillip R. Ward, Jr.**

Ms. LaShondra Stringfellow, Asst. Director of Planning delivered the staff report by describing the location of the property stating the Commission will be reviewing a site plan, landscape plan and tree mitigation plan at a later date. There is a detention pond on the southwest corner as well as a landscape buffer easement which needs to be dedicated on the

recorded plat because the applicant is requesting to utilize the 50' buffer as opposed to a 6' masonry wall. Staff recommends approval of the preliminary plat and layout plans which comply with the Subdivision Regulations, all applicable city ordinances and design standards. Application was deemed complete on July 21, 2016.

Mr. Cannon Henry, P. O. Box 120051, Arlington indicated this was a 4.8 acre tract of land and only half of the site was being developed.

Commissioner Hamilton asked where Destiny Worship Center is currently located.

Pastor Ward, 7510 E. Grand Ave. Dallas indicated the church is located in Lancaster.

Commissioner Deeds made a motion to recommend approval of Case 16-20. The motion was seconded by Commissioner Hamilton. The vote was as follows:

**V. Case 16-23 – Review and consider a final plat plans for the Hillcrest Addition, Section 3, Block 1, Lot 6, located on the south side and at the terminus of Maplegrove Drive, north of Crestway Drive; requested by Jay Childs on behalf of Hillcrest Baptist Church.**

Ms. LaShondra Stringfellow, Asst. Director of Planning delivered the staff report describing the location of the property. Staff finds that the final plat complies with the Planned Development –Site Plan, the preliminary plat, the Subdivision Regulations and all applicable city ordinances and design standards. Staff recommends approval. Application was deemed complete on July 21, 2016.

Mr. Jay Childs, 209 E. Main St., Waxahachie, asked if the Commission had any questions.

Commissioner Hamilton asked if infrastructure had already started on the property.

Mr. Childs indicated that they had received a grading permit and were grading but no infrastructure had been started.

Commissioner McCurdy made a motion to recommend approval of Case 16-23. The motion was seconded by Vice-Chairman Strother. The vote was as follows:

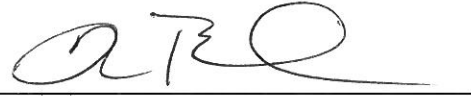
Chairman Brooks declared the motion carried.

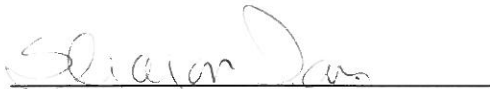
