I. Call the Meeting to Order.

Vice-Chairperson Auzenne called the meeting to order at 6:00 p.m. declaring it an open meeting in which a quorum was present, and the meeting notice was duly posted.

IV. Public Hearing Items:

1. Case No. CUP-354-2021 – Conduct a public hearing and consider an application for a Conditional Use Permit for the sale of alcoholic beverages for on-premise consumption in conjunction with a restaurant on property zoned "LR" (Local Retail District) within the Uptown Overlay, generally located east of Uptown Boulevard, south of West FM 1382 with the approximate address being 642 Uptown Boulevard, Suite 202.

Representative: Gena Cannon, All Tex Permits

Applicant: Thayla Williams, Sista Bayb's

Property Owner: Katrina Parsley, Cedar Hill Shops, LLC

Planner Katherine Linares briefed the Commission on the request. She indicated that staff recommends approval subject to the following conditions:

- 1. The operation of the use is subject to the site plan and floor plan with attachments and the requirements in Section 4.1.4 of the Zoning Ordinance.
- 2. This Conditional Use Permit is only valid for the operator "Sista Bayb's". A new CUP shall be required if the operator on the TABC license changes.
- 3. There shall be no walk-up window access.
- 4. The drive-through facility shall not be utilized without reconsideration of the Conditional Use Permit.
- 5. Commercial amusement uses shall require an amendment to the Conditional Use Permit.

Vice-Chairperson Auzenne asked if there were any questions from the Commissioners. There were no questions.

Vice-Chairperson Auzenne asked the applicant to come forward and address the Commission. Thayla Williams, business owner, at 8135 Tierra Del Sol Road, Arlington, TX, 76002, addressed the Commission and stated she was available to answer questions.

The Commission asked Ms. Williams about her business operations. Ms. Williams indicated that this is her only restaurant, which serves seafood for lunch and dinner. Ms. Williams asked about patio seating, which she was told could be added at a later time.

The Commission asked staff about the history of the property and the different restaurants which have occupied the suite.

Vice-Chairperson Auzenne opened the public hearing. She asked if there was anyone wishing to speak in support or opposition of this request.

No one spoke in support or opposition.

Vice-Chairperson Auzenne closed the public hearing.

Commissioner Thierry made a motion to approve subject to staff's conditions.

The motion was seconded by Commissioner Flores.
