
FY2024 BUDGET REDUCES PROPERTY TAX RATE; FUNDS PUBLIC SAFETY & NEW LIBRARY, MUSEUM & PARK

Last month the Cedar Hill City Council approved the Fiscal Year 2023-2024 budget, which reduces the property tax rate by one cent \$0.646525 per \$100 valuation.

The budget maintains the services, infrastructure, and amenities that are the foundation of everyday life in Cedar Hill for \$4.96 per day for the average homeowner. The budget also funds an investment in Public Safety personnel and equipment and the operations and maintenance for the new Library, Museum & Signature Park set to open in Spring 2024.

CEDAR HILL ISD 2023 VATRE



Through a voter approved tax rate election (VATRE), Cedar Hill ISD is expected to generate an additional \$6.8 million a year! The extra funds will be used towards:



9 NEW CAMPUS POLICE OFFICERS

- Currently, there are no police officers serving CHISD elementary schools.
- CHISD must spend \$848,200 to add police officers to every campus to comply with House Bill 3.



INCREASING TEACHER PAY

- If approved by voters, CHISD will provide stipends in Jan. 2024:
- \$2,500 stipend with benefits for all teachers, counselors, librarians & nurses (\$1.18M)
- \$1,000 stipend with benefits for all staff including bus drivers, paraprofessionals, custodians etc. (\$1.05M)



PROTECTING FINANCIAL STABILITY

- The state has not added new funding to schools despite rising costs due to inflation.
